The application received in the prescribe proforma will be digitized in SUVIDHA application.

Permission for vehicles, etc., shall be issued by RO concerned and applicants for the same shall be processed through Nodal Officer (SUVIDHA incharge in the DC Office). The permission will purely be granted on first come first serve basis.

Upon granting permission, a copy of the permission along with filled up Proforma in Annexure D1 shall be immediately furnished to the Nodal Officer, Control Room & Nodal Officer, EEM for onward transmission to Flying Squads and Video Surveillance Team for covering the event.

In this regard, all Candidates/Election Agents and Political Parties are hereby directed to strictly adhere to the above directions.
