Upon extending his welcome to the members, he gave an outline on the meeting's purpose and apprised the members on the schedule of the forthcoming General Election to Village Council, 2025 under Khawzawl District.

**1. Model Code of Conduct (MCC) :** The Chairman apprised the meeting about the overview of the rules and regulations of the Model Code of Conduct (MCC) as mandated by the State Election Commission.

**2. Queueless Polling Station :** After much deliberation among the members, it was decided that District Election Officer, Khawzawl will issue a letter to the Mizoram People's Forum, Khawzawl District and Sub Headquarters YMA, Khawzawl requesting them to make necessary arrangement for the said queueless polling station General Election to Village Council, 2025. General guidelines for queueless polling stations will be prepared by the District Election Officer, Khawzawl and provided the same to them.

**3. A.O.B :**

**a. Voter Turnout :** To enhance voter turnout in Khawzawl District, the following steps were agreed upon:

- i. Digital Flyers :** The District Information and Public Relations Officer (DIPRO), Khawzawl will prepare digital flyers encouraging citizens to cast their votes.
- ii. Appeal through Pastorates:** The District Election Office, Khawzawl, will issue a letter to all pastorates within the district, urging them to promote voter participation in the election 2025.

The chairman then requested the representatives of the security personnel to provide updates on their preparations for the upcoming election. To conclude the meeting, the Chairman expressed gratitude to all members for their participation and ended the meeting with a vote of thanks.
